

Anti-Bribery Policy Statement

PETROLCOM Oil & Gas Services have a zero tolerance attitude towards bribery and corrupt practices in all their business dealings. Anti-bribery provisions are included within our standard Terms and Conditions of Sale which are attached.

Following the passing of legislation in the United Kingdom this document formally sets out the expectations of PETROLCOM Oil & Gas Services in how business is conducted and transacted by PETROLCOM Oil & Gas Services with you as a buyer of PETROLCOM Oil & Gas Services product, and how you as a customer of PETROLCOM Oil & Gas Services may transact business with your customers in respect of the products supplied by PETROLCOM Oil & Gas Services.

It is expected that you will

Comply with all applicable laws, regulations, codes and sanctions relating to anti-bribery and anti corruption including, but not limited to:

Local and national laws in the territory you operate.

The UK Bribery Act 2010.

The US Foreign Corrupt Practices Act 1977.

The UN Convention Against Corruption.

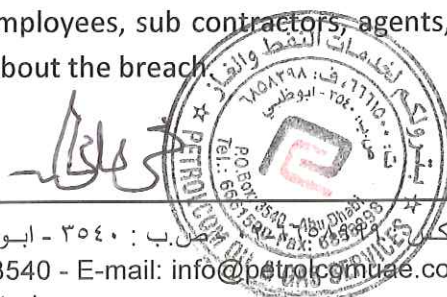
Comply with the anti-bribery and anti-corruption provisions in the standard Terms and Conditions of Sale of PETROLCOM Oil & Gas Services.

Ensure that all parties with whom you are associated or who are providing goods or services in connection with the goods supplied by PETROLCOM Oil & Gas Services under their standard Terms and Conditions of Sale (including subcontractors, agents, consultants and other intermediaries) are aware and comply with the requirements of this document.

Maintain complete and accurate records of all transactions and payments made in connection with goods supplied by PETROLCOM Oil & Gas Services under their standard Terms and Conditions of Sale, and, on reasonable request, disclose details of those transactions and payments to PETROLCOM Oil & Gas Services.

On reasonable request confirm in writing to PETROLCOM Oil & Gas Services that you have complied with requirements of this document, and if so requested, allow PETROLCOM Oil & Gas Services to verify this compliance by way of an audit of your records.

Immediately inform PETROLCOM Oil & Gas Services if you suspect or become aware of any breach of the requirements of this document by one of your employees, sub contractors, agents, consultants or other intermediaries and provide detailed information about the breach.



You will indemnify, keep indemnified and hold harmless (on a full indemnity basis) **PETROLCOM Oil & Gas Services** against all costs, expenses and losses that **PETROLCOM Oil & Gas Services** incurs or suffers as a result of any breach by you or any of your associated parties of the obligations of this document. This indemnity will not apply to any fine levied on **PETROLCOM Oil & Gas Services** as a result of **PETROLCOM'S** criminal liability.

If you breach the obligations of this document then **PETROLCOM Oil & Gas Services** shall have the right to terminate any order or contract governed by **PETROLCOM Oil & Gas Services** standard Terms and Conditions of sale without notice and with immediate effect and **PETROLCOM Oil & Gas Services** will be in no way liable to you in respect of such termination for payment of damages or any other form of compensation.

We request that you make relevant employees and other parties aware of the contents of this document and seek your assurance that you will take action to ensure that to the best of your ability the obligations of this document are fulfilled.
